The last similar AGM was held on 22.04.2022, (for handover by the then Executive Committee to the then Elected New Executive Committee, for which the Elections were held on 10.04.2022) at the premises of Gurudwara Nanaksar Complex.

We have sincerely attempted to take care of the problems of the residents through the offices of all Govt. agencies viz SDMC, PWD, D.J.B & Delhi Police and have endeavored to seek help from all different political and administrative setup, viz Councillor, D.C, DCP Police/SHO, MLA, M.P & Hon'ble L.G. We have been having regular meetings for followup with all senior Govt. Officials.

We have no hesitation to accept the fact that the efforts put-in by us have not been consummated, proportionately. We all shall acknowledge the fact that it is not all that easy to mobilize the resources from the Govt. Machinery mainly because of multi functional departments reporting to different political bosses & most of departments of the Govt. (viz. SDMC, Delhi Jal Board, PWD, Delhi Police are short of resources, (including manpower and the infrastructure) and also the zeal to change with the time and requirement. This left a gap between our expectations and realization of results. We shall, however, keep on working resolutely, with your support, of course, for the benefit for the colony.

Major Challenges for the RWA and the Colony

- **1.** To work for improvement in the performance of MCD, with specific reference to Sanitation, Horticulture & Roads.
 - Representation to Commissioner and Hon'ble L.G. already done copy attached.
- 2. To arrange to get a permanent office for RWA.
- 3. To augment the funds of RWA, by increase in no. of memberships. It is proposed to increase the Life Membership Fee from Rs. 1100 (since last more than 10 years) to Rs. 2100. It sis proposed to do away with Annual Membership. It is proposed to augment the number of life members by about 1000 nos.
 - At present there are 3947 members (as per voters list updated upto 29.02.2024).
- 4. Security Services for the entire colony (funds to be supported by the residents)
- **5.** To deal with builders, who keep on taxing the infrastructure of the colony by usage of backlanes and storage of building material in front as well as backlanes.
- **6.** To persuade the residents to free the encroachments on public land around the residences (especially corner plots).
- 7. To manage encroachments by vendors in the entire colony. (A PIL has been filed and the matter is sub-judice)
- 8. To tackle the issue of Water Seepage in Basements (The Case is Sub-Judice).
- **9.** To persuade DJB for comprehensive replacement of Sewerage system of the colony, which is almost 60 years old and cannot sustain the futuristic requirement because of more and more houses getting converted into multi storied buildings.
- **10.**To manage the problem of street/ stray dogs and to manage the problem of poos of pet dogs by the owners of dogs in the colony.
- **11.**To manage the growing problem of traffic & parking issues (especially around M-Block Market and Schools viz. K.R Mangalam , Don Bosco & Balwant Rai Mehta School).
- **12.**To persuade the residents to do away with un-usable/old vehicles still parked in the colony and usage of stilt for parking of cars.
- **13.** To explore the possibilities of an independent club only for the residents of GK-2. (Though the availability of adequate space is a constraint)

Membership Drive & Annual Maintenance Charges

In the last year 186 nos. new life members were inducted in the association.

Total membership of GKIIWA is about 3974 nos. (updated upto 29.02.2024).

We, all residents, have to accept the fact that no organisation can sustain itself without adequate funds.

GKIIWA is by the residents and for the residents. We should not depend upon sponsorship and Melas to support GKIIWA. Residents need to support it, in their own interest.

There are about 5000 Nos. kitchens and about 18,000 Nos. adult members in the colony. Let us imagine a very healthy and positive situation, if majority of the Life Members/families contribute towards AMC @ Rs. 100 per kitchens/ month).

We could re-shape the appearance and facilities, without too much dependence on Agencies/bureaucracy and politicians.

Infact there is a need to increase the AMC charges@ Rs.100/- month (Per Kitchen or per flat from Rs. 100 per month to Rs. 500 per month with of course increase in the spectrum of services to be provided to the residents.

Proposed package shall include the following services:-

- **1.** Cleaning of backlanes (in case the services of MCD do not improve to our satisfaction.
- 2. Development and improvement of parks.
- **3.** Handling of Kitchen Waste (from household to collection/compression center of MCD.
- **4.** To enhance the security system in the entire colony.
- **5.** To provide stickers for the Cars of Residents
- **6.** To augment the sports facility for the youth

It is worth a mention that almost all RWA'S are funded by the residents only.

(INFORMATION ABOUT ANNUAL DUES/CONTRIBUTION by the residents towards RWA Funds from the Surrounding Colonies is attached herewith for ready reference).

Explanation note on AMC

At the outset we thank the residents members (297) who contribute towards AMC in last year.

Let us all accept and acknowledge the fact that probably since last about 15 years, or so the performance of the statuary body, especially of MCD has deteriorated, gradually and with continued regularity.

This has resulted in depleting standards of sanitation and other infrastructural requirement for well being of this colony (which used to be one of the pristine colonies of South Delhi).

This colony contributes about Rs. 800 lacs per year as the property tax apart from crores of rupees collected towards sanction plans fees for development of new building etc.

Despite this much of contribution to the kitty of MCD by this colony there has been a consistent & constant neglect of the essential services to be provided by MCD to the residents.

Let us accept the fact that so far since last about 20 years we have been forced to live with this neglect and total apathy, despite the best efforts done by not only us but also by the preceding Executive Committees.

Even senior official of MCD upto the level of Dy. Commissioner and also the corporators and MLAs of our area, attribute this neglect of essential activity due to regular decrease in no. of manpower deployment.

It is learnt that the manpower has reduced from about 100 % to about 30%. There has been no replacement/replenishment of the departed manpower.

This issue has been represented by us to senior authorities as well as political big wigs a good number of times but with no useful result. Our latest representation was made to Commissioner, MCD & Hon'ble Lt. Governor on 03.05.2024 (copy enclosed herewith).

Hence the need of Annual Maintenance Charges was considered even way back in the year 2011.

It was approved in an Extra Ordinary General Meeting held on 24.07.20211 to introduce the system of AMC, collection of funds, Maintenance charges@Rs.100/- month (Per Kitchen) from residents to meet the expenses on Maintenance of Parks in the colony & cleanliness was approved by a vast majority in Extra-Ordinary General Body Meeting held on 24.07.2011,

Execution & collection of AMC, has not been satisfactory, probably for lack of efforts and conviction of the residents.

We, all residents, have to accept the fact that no organisation can sustain itself without adequate funds.

GKIIWA is by the residents and for the residents. We should not depend upon sponsorship and Melas to support GKIIWA. Residents need to support it, in their own interest.

There are probably, more than 5000 Nos. kitchens and about 18,000 Nos. adult members in the colony.

It is therefore proposed that we re-look of this requirement of AMC @ Rs. 500 Per Month/Per Kitchen or Flat (as the case may be).

Following services shall be provided by the GKIIWA in lieu of this proposed AMC.

- 1) Cleaning of Backlanes (Once a week regularly of 52 nos. backlanes in the colony, to be taken-up by the process of each block).
- 2) Collection and disposal of Kitchen Waste (through the contractor from source to decomposing station of MCD).
- 3) Provision of new gates (in all lanes, as per the permissible rules of MCD). It is worth a mention here that permanent steel gate are not permissible on PWD roads inside the colony.
- 4) Provision of security guards for all lanes, for all blocks and also on the peripherial roads (as a replacement of barricades which were earlier provided by Delhi Police.
- 5) Provision of 1 Gardner for each park of the colony (excluding central park W-S Block and Uday Shankar Park, E-Block, GK-2

It is pertinent to mention here that for past many years the parks in W, M,S and E Block are also being maintained by the efforts and monitory contribution of certain public spirited residents of the colony because of lack of adequately desired support form MCD.

Minutes of The Extra Ordinary General Body Meeting held on 24.7.2011.

The Extra Ordinary General Body Meeting was held on 24th July 2011 Sunday at 10.30 AM in the Hall of Arya Samaj, M-Block G.K-II. The meeting adjourned for 15 minutes due to lack of quorum.

Attendance: A total of 148 members attended the meeting as per signature in the Attendance Register.

Welcome by the President: The President Sh. Ashok Bagga, welcomed the members and thanked them for making it

convenient to attend this meeting.

Confirmation of the minutes of the previous meeting: The General Secretary Sh. Raj K. Gupta reported that the minutes of the A.G.M. held on 17.4.2011, had been Circulated to the members vide Circular No. 4-2011-12 dated 22nd April 2011 However he read out the minutes of the previous A.G.M. The President Sh. Ashok Bagga invited the suggestions of the members and recommended the adoption & confirmation of the minutes of the previous meeting. On which the following objection were raised:-

Sh. P.P.Gambhir said: The Annual Gen. Body meeting dated 17.4.2011 was not valid as the then President had sent

letters for its postponement. He further said that the meeting was unlawful.

Answer: Dr. Sharad Lakotia had posted few pamphlets in parks on plane paper for postponement of the meeting, on the same day morning. It was in his personal Capacity to mislead the members. It was not with the approval of G.K-II WA. Objection raised: How Sh. Mendiratta presided over Annual General body meeting.

Answer: Dr. Sharad Lakhotia did not attend the A.G.M. And the members present in the meeting dated 17.4.2011 appointed Sh. B.D. Mendiratta (Vice President) to preside in the absence of the President by clapping & voice vote. Sh.V.K. Gauba pointed out the error of writing the names of 'four' resident members under obituary column in Circular No-4-2011-12 dated 22nd April 2011.

Answer:- Letter of apology sent on 3.5.2011 to the respected residents whose names had wrongly been put under

obituary column in the Circular mentioned.

He further raised Directory 2011 issue and asked for the account of funds collected through Mrs. Indra Arora in

Advertisement account up to the tune of Rs.8.50 lakhs.

Answer:- Directory 2011 was under print and correction work including proof reading is being done and very soon its copies will be distributed among the members.

Proper accounting is being maintained of every receipt & payment. Accounts are audited by appointed Chartered Accounted every year.

Members present in the meeting said: It was unfortunate that the other group loosing Election has proceeded to the court of Law & have unfortunately challenged the 2011 Election.

The members deplored the actions of Sh. P.P.Gambhir who wasted the time of the house.

The minutes of A.G.M dated 17.4.2011 were confirmed in the House with applause.

Re-opening of Savitri Cinema.

Chairman Savitri Cinema, Action Committee Shri Chetan Sharma gave the latest information of Savitri Cinema issue to the house & narrated all the efforts made with the Co-operation of adjoining colonies R.W.A's.

- Candle light protest march on 30.5.2011 The Association held meeting with the senior advocates & retired judges of the colony for their legal advise on this issue.
- Silent peaceful march putting masks on the face on 17.6.2011.
- Meeting with Spl. Commissioner (T) and Joint Commissioner of Police (Traffic).

- Chief Minister, Smt. Sheila Dikshit.
- M.C.D Commissioner Sh. K.S. Mehra.
- Office of Honble Lt. Governor

Director UTTIPEC. He was aware of the problem and assured us to look into the matter and try for additional entry and exit points for the colony in their next meeting with L.G.

Shri Chetan Sharma took the effort to remove all the misconceptions regarding the Supreme Court order in the Savitri Complex case. He addressed a large gathering of member residents of G.K-II and brought to their knowledge the complete Supreme Court order. He emphasized on the last para of the judgement which states that the concerned Govt. Agencies can take appropriate action in the changed Circumstances with regard to Traffic congestion near Savitri Complex. This was greeted with a huge round of applause from the residents present.

The NOCs from different Govt. Agencies, submitted by D.L.F have become 8 years old in the year 2002-03 & there are changed Circumstance with increase of population and many fold motor vehicles, Multistoried luxury apartment constructed by DLF in E-Block & W-Block will increase more congestion when they are occupied by their owners after completion. Sh. P.N.Chawla, Sh.Rajneesh Goenka, Sh. Ashok Puri, Sh. S.P. Anand, Sh. P.P. Gambhir & Sh. V.K. Gauba, Ms. Lilu Bhojwani all appreciated the efforts of RWA regarding Savitri Cinema and further said to include the construction of kings Court & Queens Court Luxury Apartments in E & W-Blocks along with Savitri Cinema Complex.

The President informed the video record is being made of the apartments being built in E-Block and W-Block and will be submitted shortly with our written Presentation with UTTIPEC.

Resident members Complained of Traffic Chaos at K.R. Mangalam world School in S-Block and suggested to apply RTI to know about site plan of school including Entry & Exit gates.

The point was noted; further the correspondence with K.R. Mangalam School is already made and has asked them to send photo copy of site-plan of the School Building.

The house unanimously adopted a Resolution to fight against Traffic at K.R. Mangalam School and authorized to take

Shri JK Jain(Treasurer) Presented Income & Expenditure A/C of the Assn. for quarter ending 30.6.2011 and reported a loss of Rs. 1.48 lacs Excess of expenditure over Income. Major expenses incurred were:-

Maintenance of parks & salary paid to mails	Rs.83,000/-
A.G.M & Election expenses	Rs.53,000/-
Social activities	Rs.15,000/-
Legal & Professional Charges	Rs.44,000/-
Printing & Sty.	Rs.19,000/-

The Treasurer stressed the need of collection of more funds by way of contribution from Business House in the colony or a minimum possible levy of Rs.100/- per month each kitchen as maintenance charge to meet Association expenses for development of the colony & maintenance of parks. He further referred the court decision published in Times of India news paper dated 26.5.2011 that reads as "It is mandatory on ones part to be member of the association and pay the monthly subscription as it is carrying out welfare activities such as cleanliness of blocks & parks" (Circulated in the House). Sh.J.L Angra; objected to this & said that court judgement is not relevant & not according to constitution.

Mr. Neeraj Choudhary Advocate: said that this scheme applies to co-operative society flats only. Sh.V.K. Gauba: was of the opinion that the expenses be met from the Income which generates from Diwali Mela & Advertisement receipt of Directory.

Sh.P.N. Chawla proposed to exempt residents 70+ to be excluded from levy of this cause.

W-Block park walkers Association represented by Sh. Anup Chandra insisted the need for collection of funds for maintenance of parks, which is our 'LIFE LINE'

Except 12 members majority of members present in the meeting approved the proposal of collection of maintenance charges @ Rs.100/- per month (per kitchen) from the residents to meet the expenses on maintenance of parks in the colony & cleanliness with immediate effect.

The meeting ended with a vote of thanks to be chair.

Lunch was served to the members thereafter.


General Informative Notes

- 1. After about many years, this Executive Committee of GKIIWA has been able to obtain original Certificate of Registration with same number (S-3726) from the authorities. This Certificate has not been traceable since 1973-74; GKIIWA had been managing with the photocopy of the original certificate.
- 2. GKIIWA have filed the Income-Tax Return for the last year (first time ever).
- **3.** GKIIWA has initiated the process of Registration for getting the benefit of CSR support from Corporates. (due to the constraint of stipulated gestation period, actual benefits shall start only in 2025-26, after filing of Income Tax Return).
- **4.** GKIIWA propose to enter into PPP arrangement with Delhi Govt. for Parks. (it could not be executed earlier for want of the original Certificate of Registration, despite the intervention and support from our Hon'ble MLA.
- 5. We propose to form **sub-committees** for the followings:
 - a) Sanitation (including dealing with MCD)
 - b) Horticulture
 - c) Security Services
 - d) Review for Amendment in the Constitution of GKIIWA
 - e) To deal with Builders
 - f) To manage Stray Dogs (with win-win situation for all and as per law)
 - g) Culture & Sports Committee
 - h) Development of Digital App for the Colony
 - i) Traffic management in the colony (including around schools)

Each Committee shall have 5 members (3 nos. from Executive Committee & 2 nos. from active residents. In addition to these members, General Secretary and President shall be Ex- Officio Members of all Committees.

6. GKIIWA shall hold quarterly General Meetings with the residents, for exchange of views and information.

Guidelines for the Builders & Contribution to GKIIWA.

There is a lot of construction activity taking place in GK-2. While there is nothing wrong with that per se, it is the constant disregard of rules and regulations by the builders that t his subject has become a matter of acute consternation for residents of the colony.

GK-2, being a freehold colony, the agreements for construction are bilateral between the Property Owner and the Builder. As a result, there has not been any significant involvement of **GKIIWA** in this matter so far. However, In view of the considerable impact of the ever increasing construction activity in the colony, GKIIWA has decided to roll-out a few measures going forward to provide a semblance of rationality to the construction activity in the colony.

The suggested guidelines are annexed herewith.

We also propose that the builder should contribute to GKIIWA i.e. of the usage of infrastructure of the colony and compensation to the inconvenience caused by the builder during the re-development of the houses.

The suggested modus-operandi here as under:-

- 1. The donations/contribution shall be taken by the GKIIWA only through the mode of Cheque/Bank Transfer.
- 2. To execute this formally and legally, the builders will be asked to enroll themselves as the associate member of the GKIIWA.
- 3. The tenure of payment as well as construction activity shall be maximum 2 years per site, incase this tenure/period get crossed over, the builder shall again repeat the process of contribution, as half of the fee for 2 years.

Associate membership fee is proposed as under (depending upon the size of plot)

- a) Upto 250 sq.yds- 2 lacs for 2 years
- b) From 251 to 400 sq.yds 4 lacs for 2 years
- c) From 401 sq.yds and above 6 lacs for 2 years (This membership fee shall be non refundable & should not be considered as any form of security/refundable deposit)

Note: We shall put-up this proposal for formal approval in an E.G.M, probably in the first week of July (after review of suggestions by the residents).

This issue of builders (Guidelines etc) finds a prominent mention in our Manifesto also.

Annexure

Suggested Guidelines for Re-development of Buildings.

- 1. The construction activity should be started only after written intimation to GREATER KAILASH-II WELFARE ASSOCIATION.
- 2. Statutory by-laws and sanctioned plans should be followed.
- **3.** The Govt. has allowed liberal coverage area for development. We should not cross this limit to have more of illegal covered area.
- **4.** Demolishing and construction work should be undertaken with least possible disturbance to the residents & neighbouring buildings.
- 5. No construction activity should be carried out beyond permissible timings, especially in the evening (suggested timings are from 9:00 am earliest to 7:00 pm latest).
- **6.** There should be minimum/essential workers staying at the site.
- 7. These should be verified/registered with the Police Station, C.R Park.
- **8.** Once the basic construction of basement and Ground Floor is done, essential human activities (bathing, washing etc) should be done inside the area & not in the backlanes.
 - Such activities undertaken in the back-lanes make living miserable for the neighbourhood.
- 9. Steep and long ramps should not be provided outside the area of the building.
- **10.** There should not be any encroachment of the pedestrian path/pavements.
- 11. All buildings must have storm-water drains, with openable covers on the ramps for cleaning of storm water drains.
- **12.**All buildings must have provision, to let the water from drive-way, flow into storm water drain & not on the road, outside the building.
- **13.**All construction material should be stored/stacked as per the stipulated guidelines by MCD only.
- 14. Malba should be disposed off on regular basis. '
- **15.**Usage of JCB/Heavy construction Machine should be avoided for digging of the foundation as these cause vibrations and cracks in the adjoining buildings.
- a) If JCB'S have got to be deployed (due to rocky grounds) these machines should be deployed with the consent of the authorities (MCD, Police). And also with the consent and approval of the neighbouring residents and RWA. Such JCB's if deployed should be operated by the registered/licensed drivers for heavy machinery.
- b) If during such activities, any cracks occur in the adjoining buildings, these should be repaired immediately, to avoid further damage to the existing buildings.

NOTE A: SIGNIFICANT ACCOUNTING POLICIES AS AT 31ST MARCH 2024

a) Basis of Preparation of financial Statements

The financial statements have been prepared on mercantile basis in accounting with the generally accepted accounting principles (GAAP).
